- a) New applications for discussion

S.16/0819/FUL Wynstones School Extend the size of car park
(retrospective)

Councillors examined this application and while the need for the extended car park was recognised, it was felt that the application was misleading. The stated number of parking spaces quoted before the extension greatly differed from those quoted in previous applications. From the plans provided it was impossible to gauge exactly how many extra parking spaces would be provided. The clerk was asked to respond to the consultation and request correct and detailed information so that an informed decision can be made.
