#### 24/047 OVERWEIGHT LORRIES AND SPEEDING IN UPTON LANE.

It was disappointing that Cllr Sue Williams was not in attendance. Members of the public had attended specifically to present video evidence of speeding and multiple vehicles exceeding the speed limit or the 7.5 tonne weight restriction. After a discussion it was agreed that Mr M King should contact the MD of GTI Transport, the main culprit, with the videos, copied to the Parish Council, Chief Inspector Paul Cruze of Stroud Constabulary and Neil Coleman of Gloucestershire County Council, as he is already looking into the problems in Upton Lane. Once issued the Parish Council will need to write a letter of support. It is believed that with the video evidence, further action can be taken to gain tracker evidence, and then action can be taken against the developers as planning conditions are not being adhered to.

## 24/048 BLOCKING OF GREEN LANE NEXT TO MOUNT VIEW MULTI AGENCY MEETING

Cllr Eric Hibbert stated that there had been some positive developments, with the Liaison Officer meeting with the travellers. It is hoped that they will attend the next multi-agency meeting on 11<sup>th</sup> April. However, they have been asked not to send more that 2 - 3 representatives. If they try to attend with more than that and are intimidating, then the meeting may be curtailed for safety reasons.

# 24/049 NOISE NUISANCE REGARDING BIRD SCARER AT COURT FARM

Cllr Eric Hibbert reported that a bird scarer was starting at 6am and continued every 20 minutes throughout the day. He had spoken directly to the farm manager, and nothing had changed. Stroud District Council's Environmental Dept had visited the site and advised that the unit had been moved further away but that they would keep the action open. The scarer now starts at 8am.

## 24/050 STRUCTURAL CONDITION OF ST SWITHUN'S CHURCH

Mr Nigel Bone reported that the Church remains closed, but it is hoped that a meeting can be arranged with the conservation trust to try to address this.

### 24/051 INFORMATION FOR COUNCILLORS

Whaddon Fields – In a report from Mr Martin Coles, Black Box indicated that outline plans would probably not be determined until 2025. There was still no confirmation to the legal deadline as to when JCS can request land for their housing allocation. This could possibly be 2027. It was proposed to send a prepared letter to Alan Gouch, of Gloucester City Council, requesting further information regarding when this request may be made.
