A Member of the Parish wished to extend his sincere thanks to the litter pick team which recently undertook an excellent litter pick throughout the parish.

It was reported that the hedge 'over the road' has now been cut, he also reported upon a loose drain cover on the Highway, outside 12 Hillmead. The Locum Clerk agreed to report this matter to Highways.

It was reported that the 'Belong School' have now vacated the premises in Whaddon.

Concern was raised regarding inappropriate parking along Church Lane by a local business, it was agreed that Cllr Hibbert will speak with the business owners.

Cllr Rhodri Stokes-Rhys joined the meeting at this point.

PRESENTATION from Turley Planning Consultants.

The Council received a presentation from Turley Planning Consultants in respect of a proposed outline planning application for up to 250 properties along Nass Lane, details of Highways improvements and access were presented. Members of the Public and the Council raised concerns that the already over capacitated highways infrastructure would not be able to take any more vehicles but would await the outline application before making further comments.
