"Quedgeley Town Council re-arranged their joint meeting to the 20th August to give the PCs time to get responses in and I will then complete the joint letter on infrastructure. I am away in Lancashire that day and so the plan is to agree the draft and then wait for movement on the Stroud Plan before sending it off. Seven PCs at least will contribute. No further word from Sir Geoffrey. I have asked Piers what, if anything, might happen over the vacation but no reply. Neil Coleman's letter to Vernon Gray is of interest as it confirms for the first time that the County is not in contact at all with TW and TPA. It is rumoured that SDC have got NH to agree to the traffic impacts on the non-motorway sites but nothing is confirmed as far as I know. This should not necessarily impact on their holding declarations on the strategic sites."

### 7. TO RECEIVE AN UPDATE ON ST SWITHUNS CHURCH:

The Parish Council received the following update:-

"Following the visit of the Trustees in May, the Churches Conservation Trust (CCT) has been encouraged to continue with the project. The structural engineer has advised the CCT to run a small contract of exploratory works to further ascertain the extent of the problems; we will be informed when contractors are expected at the church."
